# <u>Proposed Local Law 2 of 2017 Amending Chapter 91 of the Code of the Village of Huntington</u> Bay Regarding Driveways and Driveway Setbacks

Anthony Guardino presented the proposed Local Law to the Board. After discussion, Jay Meyer made a motion to close the hearing, it was seconded by Dom Spada, and unanimously approved 4-0. A motion to adopt a Negative Declaration was made by Jay Meyer, seconded by Dom Spada, and unanimously approved 4-0. A motion to approve Local Law 2-2017 was made by Mayor Morrow, seconded by Jay Meyer, and unanimously approved 4-0. A transcript was taken by Laura Pinto. The hearing was closed at 7:45PM.

#### Brian & Diane Levden, 14 Taylor Road, Huntington Bay, NY 11743

Andrew J. Schmitz, Architect presented the application to the Board to construct a detached two-car detached garage. After discussion, Don Rave made a motion to approve the application, it was seconded by Dom Spada and unanimously approved 4-0. A transcript was taken by Laura Pinto. The hearing was closed at 7:45PM.

### Edward Boccard, 34 Heckscher Drive, Huntington Bay, NY 11743

Mr. Boccard presented his request to the Board to consider reopening the 2002 Inc. Village of Huntington Bay hearing and grant relief from a covenant in the decision whereas Mr. Boccard was denied a second curb cut. Two letters in support of the application were submitted. After discussion, Mayor Morrow made a motion to approve the request to reopen the hearing, it was seconded by Don Rave, and unanimously approved 4-0. A transcript was taken by Laura Pinto. The hearing was closed at 8:00PM.

### Emerald Baycrest HB Realty LLC

Paul Russo, Architect, presented the application to the Board to construct a new single-family dwelling. Kevin Natalie, Landscape Architect, presented a landscape plan to the Board. Jeff Vollmuth stated that a letter of non-jurisdiction from the DEC would be required. After discussion, Don Rave made a motion to approve the application, it was seconded by Dom Spada, and unanimously approved 4-0. A road bond in the amount of \$150,000 must be in place before construction begins. The architect will coordinate with the Building Inspector and Police Chief regarding the truck route. A transcript was taken by Laura Pinto. The hearing was closed at 8:25PM.

Daniel Enzone, 25 Soundview Drive, thanked the Board for their tireless work in remedying the puddling problem on his street.

Kirsten Gallardo, 19 Bay Road, discussed commercial vehicle laws in the Village. After discussion, Mayor Morrow directed Anthony Guardino to draft a Local Law regarding holidays.

Gail Devol delivered her report to the Board. As of March 17, 2017, 5 property taxes remain unpaid. The tax lien sale was postponed due to Snow Storm Stella and rescheduled for Tuesday, March 21, 2017.

There are two requests to reopen hearings before the Zoning Board of Appeals in March.

There were twenty-two tax grievance requests submitted to the Village of Huntington Bay.

After review, questions, and discussion, a motion was made by Jay Meyer to approve the March 2017 list of bills, was seconded by Don Rave, and unanimously approved 3-0.

#### **Police Commissioner's Report**

## Mayor's Report

Mayor Morrow commented that the construction to Village Hall is moving forward and on schedule.
