8. **Abandon/remove oil or propane tanks:** \$350 for 1st tank, \$25 each additional, \$250 if included with additional utilities, i.e., oil to gas conversions, propane tanks.
9. **New oil tanks:** \$350 for 1st tank, \$25 each additional, \$250 if included w/abandonment.
10. **Generator:** \$450 (including gas line).
11. **Generator with propane tank/s:** \$600 with 1st propane tank, \$25 each additional tank.
12. **General Plumbing:** \$350 (for all other plumbing services not listed above)
